WHO IS COVERED BY THE WARRANTY

This warranty extends to the original purchaser only. This warranty is not transferable, between homes or owners and is only applicable to residential use. Please maintain sales receipt as will be needed for all warranty claims without exception.

WHAT IS COVERED BY THE WARRANTY

Sink Direct LLC will replace without charge (excluding labor), any sink that is proven to be defective, with an equivalent replacement, within the specified appropriate period from date of purchase, to the original purchaser, provided it has been used solely in a residential application, used and cleaned as recommended and not damaged due to abuse, misuse or negligence. In the event of a warranty claim, the owner will be required to provide proof of purchase (please save the sales receipt).

CONDITIONS AND EXCLUSIONS

This warranty will not cover any damages that might be caused by the product. (Some states do not allow such limitation, so this reference may not apply to you.) Sink Direct LLC reserves the right to inspect any sink reported to be defective prior to any replacement of the sink. All decisions are final.
